


Linda Reinstein, Co-Founder and Mesothelioma Widow

Chairman Chesbro, Vice Chairman Gilmore and Natural Resources Committee Members, thank you for giving me the honor and opportunity to express support for SB 624, legislation that removes serpentine, the host rock for asbestos, as our California State Rock. I am Linda Reinstein, Co-Founder of the Asbestos Disease Awareness Organization (ADAO) and a native Californian. This afternoon, I represent more than 7,000 Californians who have been silenced by the deadly asbestos diseases. Today, my testimony is dedicated to the young asbestos victims. Traditionally, mesothelioma and asbestos-related diseases are thought only to afflict the eldest generations. However, the new patient profile shows younger women and men diagnosed with disease under the age for 50.

In 2003, my late husband, Alan, was diagnosed with mesothelioma, an aggressive cancer caused only by asbestos. Alan chose to undergo a radical surgical procedure that removed his left rib and lung, pericardium, and replaced his diaphragm. As a result Alan's asbestos exposure 40 years ago, our 10 year-old daughter watched her father slowly die from a preventable disease. Unfortunately, Alan's experience is not unique. Every year, more than 10,000 Americans die from asbestos-caused diseases, yet asbestos has not been banned in the United States.

## Asbestos is a Carcinogen

Serpentine is the host rock for asbestos.

In 1965, California designated Serpentine our state rock to promote the mining and commercial uses of asbestos.

Asbestos has no warning properties --- you can't see it, smell it or taste it.

Asbestos can cause irreversible lung damage and diseases, such as asbestosis, lung cancer, mesothelioma.
